# SECTION 4. FIRST AID MEASURES

#### GENERAL ADVICE:

#### EYE CONTACT:

#### NOTES TO PHYSICIAN:

# FIRE & EXPLOSION PREVENTIVE MEASURES

#### SPECIAL FIRE FIGHTING PROCEDURES

#### PERSONAL PROTECTIVE EQUIPMENT

The proper personal protective equipment for incidental releases (such as: 1 Liter of the product released in a well-ventilated area), use impermeable gloves (triple-gloves (rubber gloves and nitrile gloves, over latex gloves), goggles, face shield, and appropriate body protection.
